BY-LAW NO. 2013-070

GLEN TAY RE-USE CENTRE - OPERATING PROCEDURES

AND WHEREAS, Section 9 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Municipal Act or any other Act;

AND WHEREAS, Section 5 (3) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a municipal power, including a municipality's capacity, rights, powers and privileges under Section 9, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

AND WHEREAS, the Council deems it expedient to formalize 'Rules for Re-Users' in order to ensure efficient operations at the Glen Tay Re-Use Centre;

NOW THEREFORE BE IT RESOLVED THAT, the Council of the Corporation of Tay Valley Township enacts as follows:

1. GENERAL REGULATIONS

1.1 **THAT**, the Re-Use Centre – Operating Procedures, attached hereto as Schedule "A", be adopted.

2. ULTRA VIRES

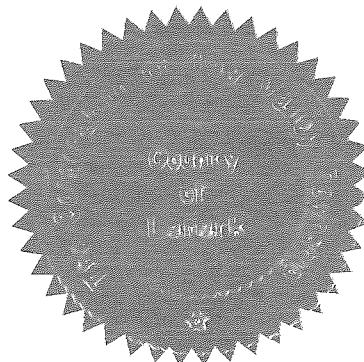

SCHEDULE "A"

Glen Tay Re-Use Centre
A project of the Tay Valley Re-Users
and
The Corporation of Tay Valley Township

The Re-Use Centre is operated by a volunteer group called The Tay Valley Re-Users, who are dedicated to the diversion of re-usable items from the landfill.

The group receives donated re-usable goods from **residents of Tay Valley Township**, sorts them and gives them away free to members of the community who can make use of them.

The Re-Use Centre's goals are:

1. to divert as many re-usable goods as possible from the landfill in order to extend the life of Township waste sites;
2. to serve as many people as possible who can make use of re-used goods;
3. to promote the practice of the 'three Rs': Reduce, Re-use, Recycle.

In support of these goals, we ask that people observe the following rules:

- The Re-Users reserve the right to limit quantities taken from the Re-Use Centre. Please do not take more than you need for your personal use.
- The Re-Users reserve the right to limit time spent in the Re-Use Centre, in order to ensure that everyone has a chance to visit and 'shop.'
- In order to record the volume of goods diverted from the landfill, donated items *must* be sorted and processed by the Re-Use Centre volunteers before being placed in the Re-Use Centre. **Generally, the Re-Use Centre is open during regular waste site hours. In the event that there are no volunteers on duty, the Re-Use Centre will be closed. Items cannot be left at the Re-Use Centre if it is closed.**
- The reselling of items from the Re-Use Centre is discouraged. This is a volunteer operation. Volunteers do not want to donate their time for others to make a financial profit.
- Any customer in violation of the rules within this By-Law will be subject to being banned from the Glen Tay Re-Use Centre for an appropriate amount of time reflective of the violation and to be determined by Tay Valley Township.
