#### 8. BY-LAWS

#### i) DRAFT By-Law No. 2022-033: Official Plan Amendment – No. 7.

Council agreed to amend section 4.3.3.2, to replace the term "Private Unassumed Roads" with "Public Unassumed Privately Maintained Roads", in the last sentence replace "is responsible for" with "generally undertakes" and to remove the word "policy" as a correction to section 4.3.4.

The Clerk also noted that the term "Private Unassumed Roads" should have been removed from Zoning section 4.3.4, in the 2016 revision to the Official Plan. The proposed revision will ensure the Official Plan reflects current treatment of these roads.

The Reeve noted that following adoption of the Official Plan Amendment, members of the public will still have the ability to submit further comments to Lanark County, as part of their approval process.

The Planner confirmed that the final version of the Official Plan will include the map schedules as displayed at the meeting. The original map files were too large to incorporate in the version that was circulated but they will be reduced and appended to the final version.
